

# BROWNSVILLE SOUTH PADRE ISLAND INTERNATIONAL AIRPORT TARMAC DELAY CONTIGENCY PLAN

The Brownsville South Padre Island International Airport has prepared this Emergency Contingency Plan pursuant to §42301 of the FAA Modernization and Reform Act of 2012. The Brownsville South Padre Island International Airport is filing this plan with the Department of Transportation because (1) this airport is a commercial airport or (2) this airport may be used by an air carrier described in USC 4321(a)(1) for diversions.

This plan describes how, following excessive tarmac delays and to the extent practicable, the Brownsville South Padre Island International Airport will:

- Provide for the deplanement of passengers.
- Provide for the sharing of facilities and make gates available at the airport; and
- Provide a Sterile Area following excessive tarmac delays for passengers who have not yet cleared United States Customs and Border Protection (CBP).

Depending on the aircraft type(s) and its operating weight(s), the Brownsville South Padre Island International Airport might have facility constraints that limit our ability to accommodate diverted flights or maintain the airport's safe operation and strongly encourages aircraft operators to contact the airport at (956) 459-1808 for prior coordination of diverted flights, except in the case of a declared in-flight emergency. Specific facility constraints include the following: Runway length, width, pavement load bearings and GSE to certain types of aircraft. These constraints are noted in the Chart Supplement record for the airport.

#### Plan to Provide for the Deplanement of Passengers Following Excessive Tarmac Delays

The Brownsville South Padre Island International Airport has limited equipment and personnel needed to safely deplane passengers from air carrier aircraft. We will utilize this equipment to deplane passengers as soon as practicable after receiving requests from the airlines. We will also provide a list of airlines, ground handlers, fixed base operators and others who may have the necessary equipment and personnel to safely deplane passengers to airlines as soon as practicable after receiving requests from such airlines experiencing excessive tarmac delays at the contact number listed above. #### Plan to Provide for the Sharing of Facilities and Make Gates Available in an Emergency

The gates at the Brownsville South Padre Island International Airport are under common use gate leases, permits or agreements to air carriers and are controlled by the airport. We direct our common use air carrier users to make gates and other facilities available to an air carrier seeking to deplane at a gate, to the maximum extent possible.

## Plan to Provide a Sterile Area for Passengers Who Have Not Cleared United States Customs and Border Protection

The Brownsville South Padre Island International Airport has defined Sterile Areas capable of accommodating limited numbers of international passengers. We will coordinate with local CBP officials to develop procedures that will allow international passengers who have not yet cleared through United States Customs and Border Protection to be deplaned into these Sterile Areas to the extent possible.
